

## Province Perks Harlem Globe Trotters Contest

THE PROVINCE PERKS HARLEM GLOBE TROTTERS CONTEST (THE “**CONTEST**”) IS INTENDED TO BE CONDUCTED IN BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. THE CONTEST IS OPEN TO BRITISH COLUMBIA RESIDENTS ONLY AND PARTICIPANTS MUST BE THE AGE OF MAJORITY OR OLDER IN THE PROVINCE OF BRITISH COLUMBIA AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**CONTEST RULES**”).

**ELIGIBILITY.** To be eligible for this Contest, an individual must:

- (a) be a legal resident of the province of British Columbia;
- (b) be of the age of majority or older in British Columbia at the time of entry; and
- (c) be a current subscriber of the Province newspaper (online or in print) as of 12:01 a.m. PT, February 1, 2011.

Employees of The Province, a division of Postmedia Network Inc., its subsidiaries, parents and/or affiliates (“**Postmedia**” and collectively, the “**Sponsors**”), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**CONTEST PERIOD.** The Contest begins at 12:01 a.m., Pacific Time (“**PT**”) on February 1, 2012, and ends at 11:59 p.m. PT on February 19, 2012 (the “**Contest Period**”) after which time the Contest will be closed and no further entries shall be accepted.

### **HOW TO ENTER.**

(a) There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.

(i) To enter online, complete and submit the entry form located at [www.theprovincecontests.com](http://www.theprovincecontests.com) (the “**Contest Website**”).

(b) Limit of one (1) entry per person per e-mail address during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.

(c) All entries become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for the Prize.

(d) Entries submitted by mail must be received by the Sponsors no later than the end of the Contest Period, and must be in a separate outer envelope bearing sufficient postage.

(e) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Each selected entrant may be required to provide the Sponsors with proof that the selected entrant is the authorized account holder of the e-mail address associated with the winning entry.

#### **PRIZE.**

(a) **Prizes.** There are six (6) prizes available to be won by the Prize winners (each a "**Prize Winner**"), consisting of: two (2) tickets to the Harlem Globetrotters game at Rogers Arena at 7pm on February 24, 2012.

(b) Each Grand Prize has an approximate value of One Hundred and Ten Dollars (CDN \$110.00).

(c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

(d) Winners may claim his/her Prize in Vancouver, British Columbia on February 20, 2012.

(e) Winner and his/her Guest must be available to attend the competition on February 24, 2012 in Vancouver, British Columbia. Should Winner and/or Guest be unable to attend on the date and time designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Winner and Guest will be responsible for (without limitation) transportation to and from Vancouver, British Columbia, any local transportation costs, travel and medical insurance, travel documentation, taxes, gratuities, telephone calls, in-room charges, meals and alcoholic and non-alcoholic beverages and any other expense not explicitly included in the Prize.

(f) Guest must comply with the Contest Rules. The Prize is awarded solely to the Winner. Guest does not have any rights to the Prize independent of the Winner, and may not travel without the Winner.

(g) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of the Prize will be forfeited and have no cash value. The Sponsors reserve the right, in its and their sole discretion, to substitute a prize of equal or greater value if the Prize (or

any portion thereof) cannot be awarded for any reason.

#### **WINNER SELECTION.**

Six (6) Winners shall be selected as follows:

(a) On or about February 20, 2012 in Vancouver, British Columbia, six (6) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

(b) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE OR E-MAIL NO LATER THAN FEBRUARY 20, 2012 NO LATER THAN 5:00 P.M. PT, AND MUST RESPOND WITHIN TWO (2) DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsors within two (2) days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

(c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

#### **RELEASE.**

Winner will be required to execute a legal agreement and release ("**Release**") that confirms Winner's and Guest's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the

The executed Release must be returned within two (2) days of the verification as a Winner or the selected entrant will be

disqualified and the Prize forfeited.

The entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Contest, without limitation.

The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors are not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing. The Sponsors are not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any Prize. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the

Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest, the Contest Website and/or canada.com.

**CONDUCT.**

By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be posted at the Contest Website and made available at 200 Granville Street, Main Floor, Vancouver, BC, V6C 3N3 throughout the Contest Period. Entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest, the Contest Website, or any canada.com website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any canada.com property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other
